# UNIVERSAL CREDIT CHANGES





#### **Managed migration**

- 2023/24 Tax Credit only claimants
- All Jobcentre areas to be included by end of March 2024
- By end of 2024/25 all other claimants, of HB, IS, JSA-IB, except for ESA-IR only claimants, to be migrated
  - Trial in some areas starting shortly, not Bedfordshire
- 2028/29 ESA-IR only claimants





#### **Support for Mortgage Interest (SMI)**

- From 3 April 2023
- Number of assessment periods before can claim reduced from 9 months to 3 months
- Zero earnings rule reduced so workers can apply
- 6 month linking rule if return to UC, can reapply for SMI and not have to wait 3 months again





#### **Backdating**

- From 29 June 2023
- Earliest day claim can be backdated to is the first day of the AP that ends on the date on which UC claim was made or treated as made
  - e.g. claim on 13/9/23, request backdating to 2/8/23 for an allowable reason which remained true through whole period. AP which ends on 13/9/23 starts 14/8/23, so claim can only be backdated to 14/8/23.





#### Childcare

- Max amounts increased for 1<sup>st</sup> time in years:
  - For one child max is now £951
  - For two or more max is now £1,630
- Awards for childcare costs under flexible support fund will no longer reduce childcare costs element
- From April 2024, working parents of 2yos will get 15 hours free childcare
- From September 2024, working parents of 9mos to 2yos will get 15 hours free childcare
- From September 2025, working parents of 9mos+ will get 30 hours free childcare





#### **Conditionality**

- Administrative Threshold:
  - Increasing from 15 to 18 hours x NMW per week
  - Intensive Work Search regime for those that don't earn this
  - No couple threshold now each claimant considered individually
  - Lead carers of children aged 3-12 will be expected to spend more hours looking for work
  - More frequent meetings for lead carers of 1yos and 2yos





#### **Earnings rules**

- Surplus earnings rule threshold stays at £2,500
- Court rules way UC operates in relation to fortnightly earnings, where some APs claimants receive 3 payslips, is not irrational so is allowed

#### **UC Phone lines**

- DWP to introduce virtual agent to UC phonelines
- They say that you can ask to speak to a person and you will still be put through



# HEALTH AND DISABILITY RELATED NEWS





#### Terminal illness claims for disability benefits

- From 3 April 2023:
  - Special rules claims can now be made if the claimant is likely to die within 12 months instead of 6

#### PIP

- From August 2023
  - Claimants with stable disabilities, or severe disabilities which aren't likely to improve, will be sent shorter 6 page review forms
- Online claims now available in some areas

#### Consultations on changes to assessments

- Consultation on reforming the WCA (before they abolish it)
  - Two driving factors appears to be the idea that more people can work from home and that exceptional circs rules being used too often
  - Proposals:
    - Change or abolish mobility, continence, getting about and socialising activities as part of WCA
    - Remove exceptional circs rules for LCWRA, i.e. excep circs only awards you LCW
- Consultation open until 30/10/2023

# **COST OF LIVING CRISIS**

#### **Spring cost of living payment**

- £301 was paid to each eligible claimant between 25/4/23 and 17/5/23
- Eligible if entitled to relevant benefits between 26/1/23 and 25/2/23

#### Disability benefit cost of living payment

- £150 was paid to each eligible claimant between 20/6/23 and 4/7/23
- Eligible if entitled to disability benefits on 1/4/23

# **IMMIGRATION RULES**

#### Sudan

- From 15/5/23:
- People fleeing Sudan who resided there before 15/4/23, left due to the violence and have either:
  - Been granted leave to remain,
  - The right of abode in the UK,
  - Or do not require leave to enter or remain in UK; are
- Exempted from habitual residence and past presence tests for benefits





# **IMMIGRATION RULES**

#### **Child Tax Credits**

- Refugees who claimed asylum before rollout of UC Full Service have been written to, to offer backdating of CTC
- As of 1/9/23, only half responded
- 'Late' claims will be allowed

#### EU

 Those who still have non-settled status will automatically be given an extra 2 years to obtain settled status, following a legal challenge





# **MEANS-TESTED BENEFITS**

#### New disregarded payments

- From 9/7/23:
- The following payments are disregarded for means-tested benefits and exempt from recovery of benefits:
  - Payments in respect of the Post Office Horizon scandal
  - Grenfell Fire compensation payments
- Vaccine Damage Payments also disregarded, but not exempt from recovery of benefits
- From 30/8/23:
- Compensation in respect of inflected blood also disregarded





# **INCOME SUPPORT**

- Compensation available for claimants who should have been advised to claim for IR-ESA when moving to ESA
- Conditions are:
  - Claimed IS on or after 31/1/11 due to ill health
  - Weren't getting IB or SDA when claimed
  - If still on IS now, need WCA and be found to have LCW
  - If have since moved onto ESA or UC, needed to have been found to have LCW when claimed
- Have to self-identify contact their local Jobcentre
